OBSERVATIONS AND CORRECTIVE ACTIONS

35- Continue to clean cookline equipment to remove greasy food debris/residues. Maintain equipment cleanliness to avert greasy food debris/residue accumulations. Observed cookline prep refrigeration/counter unit to be inoperable and have door taped closed. Observed plastic trays with worn/rough edges being used as food prep surfaces at cookline. Observed some plastic food containers to be damaged/cracked. Replace worn/missing (silicone) seals to beverage machines at counter junctions.

36- Observed beverage cups stored atop paper-lined tray at front counter.

38- Provide shatterproof light bulb/cover for light above drive-thru soda machine.

44- Organize janitorial supply room to remove accumulated trash, misc. debris and facilitate cleaning. Observed many missing tiles on bottom of mop basin.

45- Continue to clean floors throughout facility, especially under fryer equipment, to remove grease, food debris and trash. Maintain floor cleanliness to avert greasy food debris/residue accumulations. Observed missing floor and cove base tiles. Observed wall area at end of front counter (with loose wall safe) to be damaged/worn.
