OBSERVATIONS AND CORRECTIVE ACTIONS: 6- No paper towels in dispenser at cookline handsink. Paper towels replaced during inspection.

9- Observed large, deep covered container cooked noodles 58°F, for short time period, cooling inside walk-in. Noodles separated into shallow uncovered tubs during inspection. Observed covered containers of ('cooled') bulked noodles 47-49°F. Ensure temperatures of cooling noodles are 41°F, or below, using probe thermometers, prior to bulking.

14- Observed a few bowls and glasses to be soiled with some food residues after cycling through dishwasher. Soiled bowls and glasses returned to dishwasher area for recleaning.

33- Observed some dried food debris on wooden shelving storing 'clean' plastic food storage containers. Observed some dried rodent droppings in corners and hard-to-reach areas of (storage) cabinets. Shelving and cabinets cleaned during inspection. Seal holes in bottom of cookline cabinets to facilitate cleaning.

35- Discard of damaged/cracked plastic food storage containers/tubs and lids.

Reinspection fees will be charged for all subsequent reinspection unless an acceptable corrective time schedule has been submitted and approved by this Department.
