- 35- Remove tape on 2-door storage refrigerator so as to be easily cleanable.
- 36- Remove/ replace cut plastic container reportedly used for fresh herb storage/ rinsing.
- 41- Repair leaking faucet at utensil sink. Recommend providing longer riser on prespray faucet next to dishwasher.
- 44- Dust pan and brush observed on top of ice machine.

If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
