OBSERVATIONS AND CORRECTIVE ACTIONS

14/36- Observed excessive food debris on tongs kept in container on counter. Clean tongs. Clean beverage nozzles of built up residues.

34- No test strips were available for checking the level of sanitizer during inspection. Provide.

35- Clean fryers of accumulated oil and food debris. Observed ice scoop lying on top of ice machine. Store scoop in a bucket labeled, (ice only).

44- Observed soiled wiping rags on utensil sink. Reported that wiping rags are not kept in sanitizer. Store wiping rags in bucket with sanitizer in between uses.

45- Clean floors under beverage boxes in back room of accumulated debris. Clean the floor in the walk-in cooler of loose cans, bottles and cardboard.
