- 6) Refill the empty paper towel dispenser in the restroom.
- 9) Observed 4 beef roasts 110-114°F cooling stacked together (>2 inches food depth) in a pan in the walk-in cooler for a reportedly short time period. Roasts were transferred to pans to be cooled in 1 layer.
- 38) Repair the inoperable exhaust fan in the restroom. Provide a shatterproof light cover over the light in the deli walk-in cooler.
- 45) Clean the ceiling in the deli walk-in cooler to remove accumulated dust.
