OBSERVATIONS AND CORRECTIVE ACTIONS:

- 6) Store paper towel roll in the paper towel dispenser rather than storing on toilet tank.
- 7) Observed 11 Half & Half creamers 61°F (Label says "Keep refrigerated") stored at room temperature at the coffee counter. Half & Half was placed into refrigeration during inspection. Store Half & Half in the refrigerator, or provide creamers that are not required to be kept refrigerated.
- 14) Clean the beverage dispenser nozzles to remove brown residues.
- 45) Repair the damaged wall in restroom. Finish off the ceiling (bare wood beams) in the back room so as to be smooth and easily cleanable. Repair/repaint the worn wall above the utensil sink so as to be smooth, non-absorbent and easily cleanable.

Note: Reported that some areas of store will be remodeled soon. Submit plans and fee to this Department for approval prior to beginning the remodel/new construction.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department.
