32- Observed three unlabeled cans by tomato paste. Provide labels or remove.

44- Observed accumulated sunflower seeds on bottom of boxes storing bagged nuts. Clean to prevent infestations.

If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
