OBSERVATIONS AND CORRECTIVE ACTIONS: 6- Observed empty sanitary paper towel dispenser in men's restroom. Fill dispenser.
 7- Observed assorted cheeses (46°F-49°F) stacked over fill line in cheese display refrigerator (air temperature 42°F). Lower thermostat and discontinue stacking cheeses over fill line. Monitor to ensure cheese—especially soft cheeses i.e.: brie, fresh mozzarella, etc.—are maintained at 41°F or below.
 30- Observed several foods (graham crackers, chips, nuts, etc.) being stored on floor throughout store. Store all food at least 4 inches off ground.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
