OBSERVATIONS AND CORRECTIVE ACTIONS: 6- No soap or paper towels at hand sink in cake decorating area. Provide in sanitary dispensers.
 14- Observed dish drainer/clean utensils sitting on counter by one compartment sink in decorating area. REPEAT VIOLATION. All utensils shall be properly washed/rinsed/sanitized in three compartment sink or dishwasher only. Observed clean scoops stored on soiled tray on shelf over utensil sink. Store clean utensils on clean surfaces.
 34- Observed accumulated food debris/residues in utensil sink compartments and on drain boards. Clean.
 41- Observed leak at hand sink (to right of ovens) drain pipe. Repair.
 44- Observed wet mop stored in mop bucket. Store mop so as to dry completely between uses.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
