OBSERVATIONS AND CORRECTIVE ACTIONS

- 14- Observed water in wash basin of utensil sink to be 97°F. Maintain wash water at 110°F or above whenever wash basin is filled.
- 33- Observed missing laminate trim on front counter. Repair where needed to be smooth and easily cleanable. Clean inside cabinet under coffee brewer to remove accumulated debris/residues.
- 35- Observed black/tan/pink residues in hard to reach areas inside ice machine. Clean.
- 45- Observed coving to be separating from wall by entry and split in coving at corner by utensil sink. Repair.
