 6- Observed paper towels at restroom hand sink to be stacked on shelf. Provide sanitary dispenser.
 36- Observed several boxes of beverage cups, lids, etc. to be stored on floor in utensil cleaning area. Store at least 4 inches off floor on approved shelving.
 38- No shatterproof light covers on lights over front section of condiment bar (2), north side of self-service coffee area (1) or over utensil sink. Provide.
 45- Clean floor behind and under beverage dispenser to remove accumulated/pooled beverage residues.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
