- 30- Some cardboard boxes of packaged food stored on floor.
- 32- Bulk package of bagged noodle soups observed without English labels. No labels observed on some bags of fortune cookies; frozen packages of cooked vegetables; frozen containers of fish eggs (Tobiko) in display area—provide complete labels on these foods (contact distributor/ manufacturer for labels).
- 35- Replace domestic refrigerator/ freezer observed in storeroom—replacement shall be NSF approved commercial refrigerator.
- 45- Repair worn, absorbent wall behind hand sink in left restroom.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
