**OBSERVATIONS AND CORRECTIVE ACTIONS**

- 6-** No paper towels in dispenser of ice machine/storage room.
- 33-** Observed some damaged areas of kitchen counters and cabinets (i.e. peeling laminate, worn edges, rough shelves).  
Clean inside corner cabinet (at end of cabinet unit) to remove some misc. debris/residues.  
>Clean inside of cabinet under soda machine to remove rubber-type debris (from conduit).
- 35-** Clean soda machine nozzles and around ice chute to remove some encrusted and sticky residues.  
>Clean inside of Gourmet Beverage machine daily and weekly as per manufacturer's recommendation.
- 39-** Digital probe thermometer inoperable when checked during inspection. Operator replaced battery and thermometer operable by end of inspection. Ensure thermometer is readily available, especially at grill.
- 41-** Repair leak at utensil sink faucet.  
>Clean floor sink behind ice machine to remove mold and misc. residues.
- 45-** Clean floor under ice machine and remove misc. items stored under ice machine to facilitate cleaning.
