**OBSERVATIONS AND CORRECTIVE ACTIONS**

- 7, 35- Observed pre-packaged burritos, sandwiches and sausage muffins (52°F-54°F) in True display refrigerator (air temperature 53°F-56°F with thermostat on unit turned to coldest setting). Repair to maintain potentially hazardous foods at 41°F or below. Note: All food moved to other display refrigerator during inspection.
- 30- Observed boxes of food stored on floor in walk-in freezer. Store foods at least six inches off floor on approved shelving.
- 31- Observed donuts at customer self-service counter stored in rack with missing doors. REPEAT VIOLATION. Replace missing doors to prevent contamination of donuts by flies/sneezes/unwashed hands, etc. or place donuts behind front counter and have employees serve to customers as needed.
- 32- No manufacture label on bagged ice offered for sale. REPEAT VIOLATION. Provide.
- 35- Observed creamer nozzles at cream dispenser to be cut straight across. Cut nozzles diagonally. Clean inside ice machine to remove accumulated pink residues.
- 39- No thermometer in display refrigerator storing sandwiches. Provide.
- 44- Observed mop stored in mop bucket. Store mop so as to dry completely between uses.
- 45- Observed damaged areas in vinyl flooring in utensil sink area. Repair to be smooth and easily cleanable. Clean floors under beverage syrup boxes to remove accumulated dust/debris/miscellaneous trash and floor sink to remove accumulated black residues.
