**OBSERVATIONS AND CORRECTIVE ACTIONS**

- 1) No food safety certificate available. Mail/fax a copy of current certificate to this Department. Include the facility name on the fax/mailling.
- 14) Reported that tongs used for hot-held foods (i.e. burritos, corn dogs, etc.) are washed every other day. Tongs shall be washed, rinsed and sanitized at least every 4 hours.
- 31) No tongs or papers available for customer self-serve donuts – provide.
- 34) Replace the 2-compartment utensil sink with a 3-compartment sink within the next 6 months, or provide a detergent-sanitizer approved for use in a 2-compartment sink. Observed boxes of beer and other items stored on the utensil sink drainboard. Keep drainboards clean and available for utensil washing.
- 35) Repair the damaged door of the ice machine.
- 44) Reported that dirty mop water is dumped into the utensil sink. Cease this practice immediately and either install a janitorial sink or dump mop water into toilet.
- 45) Replace all cracked floor tiles in back prep area. Repair the hole in the ceiling of restroom.
