OBSERVATIONS AND CORRECTIVE ACTIONS

- 31-** Clean drain traps of both soda machines to remove mold. Clean coffee and creamer machines daily as per manufactures' instructions noted inside machines. Clean inside microwave to remove food debris/residues.
- 33-** Properly finish off/repair bare/rough/damaged and hard-to-clean areas of (makeshift) retail food and beverage counters.
–Observed back wall of cabinet storing beverage machine compressors, and through which beverage lines pass, to be damaged and with large cutout. Properly repair to facilitate cleaning and be vermin proof.
- 35-** Observed some damaged/torn door seals for retail display refrigerators and walk-in.
- 38-** Observed no shatterproof covers for fluorescent lights in back storage room (at freezer) or at retail beverage display.
- 45-** Observed vinyl floor to be peeling at self-cove in back room. Clean floor and wall at beverage syrup box rack (in office) to remove accumulated sticky residues.
