- 14) Wash water temperature was 92°F at time of inspection. Maintain wash water at or above 110°F while washing utensils. Observed a wet towel on the clean-side utensil sink drainboard. Air dry utensils on a non-absorbent surface (i.e. dish rack or the clean drainboard).
- 34) No test strips available for checking quaternary ammonia sanitizer levels at the utensil sink – provide. Note: Chlorine test strips available.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
