OBSERVATIONS AND CORRECTIVE ACTIONS

- 7, 35-** Observed foods (raw prawns, chicken tofu) in top portion prep refrigerator 45-50°F.
- 14-** Reported that prep sink is 'cleaned' with soap/bleach-water solution. Properly clean sink with hot soapy water, rinse and then sanitize.
- 29-** Label all spray bottles as to contents.
- 35-** Clean undersides of wok pans at wok range, especially hard-to-reach areas, to remove accumulations of greasy food debris/residues.
- 36-** Observed ice scoop stored in (paper covered) straw container at beverage area. Ice scoop removed from straw container during inspection.
- 40-** Observed a few (damp) wiping rags stored atop prep refrigerator and wok range at cookline.
- 41-** Repair leak at prep sink faucet.
- 45-** Clean wall and window/window tracks behind slicer and wall behind prep sink to remove food residues. Observed cove tiles under sink and wall tiles below urinal of men's restroom to be damaged/missing.
