 9) Cooking temperatures not consistently checked.
 14) Cutting board not cleaned and sanitizer after cutting raw meat and was not in continuous use. Clean after each use.
 27) Some raw produce was stored in bottom of prep refrigerator with raw meat in top bins above. Produce was relocated.
 35, 36) Clean knife rack of residues. Clean walk-in shelves of rust and sticky residues.
 45) Clean floors under large equipment of food debris, grease, and misc. debris. Clean walls near cooking equipment of grease and food residues.
