OBSERVATIONS AND CORRECTIVE ACTIONS: 9- Observed diced cooked sausage (55°F, 2 hours) cooling in refrigerated drawer under grill. Cool foods in walk-in refrigerator so as to cool foods quickly and maintain air temperature of 40°F or below in refrigerated drawers.

33- Observed missing laminate on shelf in wait station. Replace or paint to facilitate cleaning.

35, 45- Observed ice build up on door to walk-in freezer/ice pushing cove base tiles off wall and missing cove base tile at entry to walk-in freezer.

Repair. Note: Manager reports repair scheduled.
