OBSERVATIONS AND CORRECTIVE ACTIONS

- 1- No current food safety certificate available at time of inspection. Fax copy of food safety certificate to this Dept (include name of facility on fax).
- 5- Food handler observed starting work without washing hands before handling food containers.
- 6- Replace paper towel dispenser on wall at hand sink in prep area—paper towel dispenser observed lying on shelf.
- 30- Replace large plastic "refuse container" used for storage of corn meal with an approved food grade container. Replace cut plastic cup, used for dispensing cheese, with a handled scoop.
- 35- Generally clean shelves, of some dust accumulation and misc. food debris.
- 39- Replace missing thermometer in prep refrigerator (39° F).
- 41- Repair leaking hot water faucet at utensil sink.
- 45- Replace damaged floor in storage/ washing machine room. Finish installing floor in restroom so as to be smooth, easily cleanable, durable, self-covered and in good repair. Replace missing cove base tiles in kitchen; regrout kitchen floor, where grout has eroded out more than 1/8 inch (ie: near utensil sink).
