**OBSERVATIONS AND CORRECTIVE ACTIONS**

14- Food handler unaware of proper utensil cleaning procedure. Proper utensil cleaning procedure is 1. Wash with hot, soapy water, 2. Rinse with clear water, 3. Sanitize with approved sanitizer (i.e.: 1 oz bleach to 4 gallons water), 4. Air dry on clean drain board.

21- Hot water at utensil sink faucet 116°F-117°F. Adjust/repair hot water heater to maintain 120°F or above.

31- Food handler reports beverage machine nozzles are removed for cleaning every other day. Remove for cleaning daily.

39- No thermometer in display refrigerator storing milk, eggs and sandwiches and no digital probe thermometer available for checking hot holding temperatures of potentially hazardous food (i.e.: tornados, chili, etc.). Provide.
