- 1- No food safety certificate available.
- 6- No paper towel dispenser at hand wash sink. Install towel dispenser.
- 9- Observed fresh salsa in deep covered container in walk-in refrigerator at 54 °F. Cool potentially hazardous foods in shallow uncovered containers.
- 27- Observed raw eggs stored on upper shelves above cheese in walk-in cooler. Observed raw meat stored next to tomatoes and raw shrimp stored above produce in Walk-in cooler.
- 35- Store tongs in a clean area where they cannot be contaminated by food handlers.
- 40- Observed wiping rag on shelf in walk-in refrigerator. Removed during inspection. Store wiping rags in sanitizer buckets.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
