OBSERVATIONS AND CORRECTIVE ACTIONS:

- 14, 34- Replace existing 2-compartment utensil sink with an NSF approved 3-compartment utensil sink so as to facilitate utensil washing. Sink compartments shall be large enough for the largest utensil to be washed.
- 30- Relabel bulk food containers as needed.
- 40- a) Soak used cleaning rags in container of sanitizer (ie: 1 ounce bleach in 4 gal water)—use test papers to check concentration of sanitizer.
- b) Obtain linen service for laundering of cleaning rags/ towels rather than washing cleaning rags/ towels in a bucket in the janitorial sink.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
