**OBSERVATIONS AND CORRECTIVE ACTIONS:**

- 35- Observed magnetic knife rack, and knives attached to rack, to be soiled with sticky-type residues. reported knives are not used and will be and will be relocated to facilitate cleaning. –Clean wire shelving of utensil storage rack (at end of utensil sink) to remove greasy residues and dusty debris.
- 39- Provide (digital) probe thermometer, accurate at the tip, for checking foods' final internal cooking/reheating temperatures. –Provide visible internal thermometer for walk-in cooler.
- 44- Organize/remove accumulated items stored atop walk-in cooler to facilitate cleaning.
- 45- Observed vinyl-comp tile floor to be damaged (i.e. cracked, worn with holes), especially at self-coving along floor/wall junctions.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
