When Time-Only used as method of ensuring Public Safety, pans storing Time-Only foods shall be marked with discard time.

Note: Observed written procedure posted on wall by grill including discard times of 3pm and 7pm.

If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
