OBSERVATIONS AND CORRECTIVE ACTIONS: 30- Observed popcorn kernels stored in uncovered container and liquid butter flavoring stored in open carton in cabinet under popcorn machine. Keep foods tightly covered to prevent infestations.
 35- Replace ice bins with NSF approved integrated ice bins. Clean inside ice machine to remove black residues.
 36- Observed accumulated residues in beverage gun holders and beverage gun at far right station. Clean
 44- Observed unsecured CO2 tank behind bar across from popcorn machine. Secure to rigid structure.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
