- 1) Food employees did not know correct order for using 3 compartment sink.
- 41) Very low flow of water from utensil sink faucet. Repair.
- 45) Clean floors in hard to reach areas of food debris and grease. Repair missing or damaged floor tile/coving. Regrout between floor tiles were worn.

If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
