- 6- No paper towels at drive thru hand sink. Provide.
- 14- Observed wash water in first basin of utensil sink at 96°F with dissipated soap. Maintain wash water at 110°F or above whenever wash basin is filled. Discard water whenever soap bubbles dissipate.
- 35- Observed accumulated residues behind nozzles of drive thru beverage dispenser. Clean. Replace missing leg on prep sink by utensil sink.
- 44- Observed gap under back door. Provide weather strip to prevent entrance of vermin.
- 45- Observed missing/damaged cove base tile and cove base tile separating from wall throughout facility. Repair where needed.
