- 33) Repair/replace damaged/worn cabinets (under soda dispensers at drive through and in customer area) so as to be smooth, durable and easily cleanable.
- 35) Repair leak at soda lines for soda dispenser in customer area.
- 45) Repair loose sheet metal floor coving on wall near hand sink.

If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
