- 34- Obtain test papers for checking sanitizer level in sanitizing compartment of utensil sink.
 - 35- Replace damaged door frame in walk-in cooler—replacement shall be smooth, easily cleanable, non-absorbent, durable and in good repair.
 - 39- Replace burnt out battery in digital probe thermometer. Use digital probe thermometer to check final temperatures of cooked foods.
- Food preparation/ cooking primarily for catering (mainly to go/ delivery) and for farmer's market booths. No food preparation occurring at time of inspection.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department.
