**OBSERVATIONS AND CORRECTIVE ACTIONS**

**27-** Observed bowls of shellfish stored directly atop raw produce, wrapped/packaged and unwrapped/opened raw fish/meats stored atop raw produce and/or on shelves above raw produce in refrigerators. Organize freezers to rotate stock, remove/separate 'personal' foods to facilitate cleaning.

**35-** Continue to clean cookline equipment to remove some blackened food debris/greasy residues and dust. –Clean inside/bottom of slide-top refrigerator to remove some pooled liquid and mold.

**38-** Clean hood baffles to remove greasy residues.

**44-** Continue to organize/remove accumulated personal items, unused/inoperable equipment and misc. items not necessary to facility's operation.

**45-** Clean floors in hard-to-reach throughout facility to remove food debris/residues, dust and some trash.
