OBSERVATIONS AND CORRECTIVE ACTIONS

- 1-** Food safety certificate expired and food employee lacking food safety knowledge. At least one person currently working at this facility shall take and pass an approved food safety exam within next 60 days.
- 26-** Some shrimp was defrosting in utensil sink with no water running. Defrosting shall be done under cold, running water for not more than 2-hours or in refrigerator.
- 34-** Utensil sink was not available for cleaning of bowls and cutting board because of raw chicken in sink compartment. Either provide separate prep sink, or thaw meat in small batches earlier in the day so that utensil sink is readily available for utensil washing during the day. Make sure utensil sink is washed and sanitized after raw meat has been in sink
- 33-** Seal rough edges of wooden shelving affixed to wall above prep table/handsink.
- 35-** Continue to clean all cookline equipment (surfaces, between and hard-to-reach areas) to remove accumulated food debris/greasy residues.
- 40-** Discard remaining raggedy wiping rags. No sanitizer detected in tub used for storing wiping rags. Use and maintain designated container of sanitizer solution to store in-use wiping rags. Change sanitizing solution every two hours or when sanitizer levels get low. Do not leave wiping rags laying around on equipment.
- 45-** Clean floor near water heater to remove food/misc. debris/residues. Temporary floor patches acceptable on temporary basis but floor will need to be properly repaired with continuous, commercial grade flooring. Finish repairing holes in walls and ceiling of facility. Observed areas of peeling paint on ceiling.

Note: Food containers at cookline and squeeze bottles and buckets of sauces shall be maintained clean. Canned foods shall continue to be stored in food grade containers once cans are opened.
