OBSERVATIONS AND CORRECTIVE ACTIONS

- 9- Observed several packaged whole chickens, which had reportedly been cooked, hot held and cooled, in walk-in refrigerator with condensation on inside covers. When cooling whole chickens, remove cover and place immediately in walk-in refrigerator. Use digital probe thermometer to ensure whole chickens reach 70°F within 2 hours and 41°F or below within an additional 4 hours.
- 14- Food handler reports slicer cleaned by wiping with sanitizer. Proper slicer cleaning procedure is wash/rinse/sanitize.
- 31- Clean behind nozzles of beverage dispenser to remove accumulated residues.
- 36- Observed electrical tape on container storing cups and lids on deli display case. Remove tape to facilitate cleaning. Clean container to remove residues.
- 38- No shatterproof light covers on lights over open food storage containers in storeroom. Provide.
- 41- Observed leak at utensil sink faucet. Repair.
- 44- Observed mop stored in bucket. Store mop so as to dry completely between uses.
- 45- Clean floors in hard to reach places (under utensil sink, behind fryers, under shelves in walk-in refrigerator etc.) to remove accumulated residues/food debris/miscellaneous trash. Re-secure loose/separating top set coving on deli display case.
