 7- Observed buffalo wings (103°F-107°F, 45 minutes) and teriyaki wings (113°F-126°F, 45 minutes) in hot holding display case. Use digital probe thermometer to ensure potentially hazardous foods in display case are maintained at 135°F and above. Buffalo and teriyaki wings reheated to 165°F during inspection. Numbers indicating levels of heat on dial for display case thermostat no longer visible. Replace.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department.
