OBSERVATIONS AND CORRECTIVE ACTIONS: 14- Food employee in sea food department reports cutting board "cleaned" by washing with sanitizer. Proper cutting board cleaning procedure is wash/rinse/sanitize after each use or every four hours of continuous use.

34-Observed two compartment utensil sink in seafood department. REPEAT VIOLATION. Replace with approved three compartment sink with dual integral drain boards within six months.

35- Observed dairy walk-in refrigerator drainage pipe to be missing drain. Adjust and secure pipe to maintain drainage area in dry manner.

41- Observed hot water valve on mop sink faucet to be leaking. Repair.

45- Clean floors under shelves along back wall in storage area to remove accumulated dust/debris/miscellaneous trash.

If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
