14- Food handlers report utensil cleaning procedure of wash and sanitize. Proper utensil cleaning procedure is wash/rinse/sanitize.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
