35) Replace cracked door on hot holding cabinet. Clean knife racks of residues. Clean can opener holder of sticky residues. Unable to check small black refrigerator. Monitor for proper temp.

39) All probe thermometers were 10° F or more off. Recalibrate or replace.

40) Wiping rag sanitizer buckets all had low sanitizer levels. Change more often.

45) Clean floors of misc. debris in hard to reach areas. Repair damaged tile coving at dishwasher and mop sink area. Note: Make sure new restroom floor has self-coved base.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
