OBSERVATIONS AND CORRECTIVE ACTIONS: 33 –Paint wood cabinet under hand sink to be smooth, easily and nonabsorbent.
35- Manager reports beverage machine nozzles are removed for cleaning once a week. Remove/clean nozzles each day beverage machine is used.
45- Clean walls and ceiling above beverage syrup boxes to remove beverage residues.

Note: Verify REMCO "shovel" used to scoop ice from ice machine is a food grade, approved ice scoop.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
