OBSERVATIONS AND CORRECTIVE ACTIONS

- 5) Observed food employee scoop ice using unhandled cup rather than using the designated ice scoop.
- 36) Replace the damaged plastic tub (melted with large hole in side) used to store lettuce in the walk-in cooler. Observed ice scoop handle stored on top of ice in the ice machine. Store ice scoop so that handle is stored outside of the ice.
- 40) No quats sanitizer detected in sanitizer buckets and water was turbid. Change sanitizer solutions more often when water becomes dirty and to maintain sanitizer at 200 ppm.
- 45) Re-grout the tile floor throughout the facility where grout has eroded. Clean floors under the paper wrapper storage shelves to remove trash/food residues.
