OBSERVATIONS AND CORRECTIVE ACTIONS

- 14- Employee reports beverage dispenser nozzles are cleaned weekly. Wash/rinse/sanitize daily.
- 31- Observed bottles of Vital water stored in container of still water. Drain water. Ice shall be properly maintained when used to cool/store beverages.
- 32- No manufacturer's label on bagged ice offered for sale by front counter.
- 34- Utensil sink blocked by multiple boxes and trash cans. Relocate boxes/trash cans to keep utensil sink fully accessible for utensil (jerky tongs, ice scoop, beverage nozzles, etc.) washing.
- 35- Clean inside ice machine to remove pinkish residues.
