OBSERVATIONS AND CORRECTIVE ACTIONS

- 6- Refill empty paper towel dispenser in restroom.
- 35- a) Clean major equipment of misc. food debris (ie: frosting).
- b) Replace ripped door seals on freezer and front refrigerator.
- c) Repair broken storage freezer in prep area—chest freezer currently being used in back storage area until freezer in prep area is repaired.
- 38- Replace missing end caps for light sleeves—lights above storage freezer.
- 39- Replace broken thermometer in 2-door refrigerator—actual refrigerator temperature (37° F).
- 40- Used cleaning rags observed on various counters.
- 44- Continue to clean/ organize items stored in back storage area—eliminate unused items so as to eliminate clutter and facilitate cleaning.
- 45- Clean floors, in hard to reach areas of food debris (ie: under equipment, etc). Repair damaged area of ceiling in corner of prep area (near hood).

Note: No 4th quarter water sample taken at this time—take water sample before Dec. 31, 2007.
