 Observed two spray containers Hot Shot Ant & Roach killer in cabinet under hand sink. Remove domestic insecticide from facility. REPEAT VIOLATION.
 33- Observed hanging laminate trim on cabinets by espresso machine and missing laminate trim on cabinets behind front counter. Repair/replace to be smooth and easily cleanable.
 39- No thermometer in espresso refrigerator. Provide. Relocate thermometers in sandwich prep refrigerator and upright refrigerator in back room so temperature is clearly visible.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
