OBSERVATIONS AND CORRECTIVE ACTIONS: 6- No paper towels at hand sink by utensil sink. Provide in sanitary dispenser. Note: Paper towel roll observed on shelf by refrigerator. Provide sanitary dispenser for paper towels at hand sink to prevent contamination of paper towels and/or food handler hands.

14- No detectable sanitizer in 3rd basin of utensil sink. Sanitizer tablets added during inspection.

29- Observed two spray containers Hot Shot Ant and Roach under mop sink. REPEAT VIOLATION. Remove domestic insecticide from facility.

33- Observed water damaged wood and missing/hanging laminate on shelves at front counter. REPEAT VIOLATION. Repair to be smooth and easily cleanable.

35- Clean can opener and behind and between nozzles of beverage dispenser and to remove accumulated residues.

36- Observed CO2 tank by espresso machine to be unsecured. Secure to rigid structure.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
