OBSERVATIONS AND CORRECTIVE ACTIONS: 6, 21) No warm water at handsinks.

7) Sausage on display was 115-140°F. Stir and check temperatures more often.

9) Do not cover and stack potentially hazardous foods while cooling.

14) Some food debris observed on slicer and can opener. Clean more thoroughly.

30) Ice bucket not labeled "For Ice Only".

31) No food shield or other protection over English muffins at buffet.

36) Ice scoop stored on glove. Store in clean, easily cleanable container.

39) Some probe thermometers not accurate. Calibrate probe thermometers more often.

41) Repair leak at dishwasher.

Note: Evening food dispensing at bar not observed.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
