41- Repair leaky utensil sink faucet. *Repeat violation.*

45- Observed damaged floors (i.e. separation at seams, gouges, soft sub-floor) in walk-in and kitchen.

Note: To avoid reinspection fees, noted repeat violations shall be corrected by next routine inspection.
