OBSERVATIONS AND CORRECTIVE ACTIONS

- 35) Repair or replace the damaged/rough countertop in the front coffee prep area.
- 36) Observed stirring spoons stored in still turbid water at coffee prep counter.
- 40) Observed soiled wiping rag stored in a container with a little sanitizer solution. Change wiping rags when soiled and cover rags completely with sanitizer solution between uses.
- 45) Repair the damaged sheet vinyl flooring under the back prep refrigerator. Clean floors (including floor sinks) under utensil sink and storage racks to remove accumulated food/misc. debris.
