OBSERVATIONS AND CORRECTIVE ACTIONS:

- 7) Cooked BBQ chicken pieces were 113-140°F in hot case. BBQ chicken was reportedly at end of hold time and was discarded. There was no visible time tagging to keep track of hot foods. Hot case was turned up a little. Monitor hot case food temperatures more often.
- 16) Shellfish tags are just tossed into a box. Keep in chronological order.
- 45) Regrout between floor tiles in cooking area.

Note: It is understood that most foods (except lunch meats) are brought in pre-cut. Only block cheese is vacuum packed in this store.

Reinspection fees will be charged for all subsequent reinspections unless an acceptable corrective time schedule has been submitted and approved by this Department. If, for any reasons beyond your control, you cannot correct the indicted violations by the next scheduled time, call this office prior to the inspection day.
