OBSERVATIONS AND CORRECTIVE ACTIONS

- 4-** Observed food handler's open beverages on shelf of deli storage refrigerator. Beverages covered/removed during reinspection.
- 5-** Observed non-handled disposable plastic containers being used as scoops to dispense deli salads from bulk containers; containers also stored within salad products. Reported that handled spoons will be used to properly dispense salads.
- 27-** Observed unseasoned and seasoned raw chicken parts/rotisserie chickens stored in uncovered tubs atop boxed chicken and on rack inside deli/meat department walk-in cooler. Observed bulk containers of coleslaw, stored in deli upright refrigerator, covered with butcher paper.
- 29-** Observed chemical spray bottles stored hanging on shelf directly above chicken prep sink..
- 35-** Clean under/hard-to-reach areas of stabilizer clips for electric slicers on prep tables to remove dried food debris. Observed rusted shelves in deli kiosk prep refrigerator.
- 45-** Replace missing ceiling panel above deli utensil sink.
