8) Pizzas in hot case were 105-135°F. Hot pizzas are reportedly only kept for 90 minutes but some pizzas were either kept in unit longer or the time tagging was inaccurate.

14, 35) Pizza prep table cutting board and rails are only cleaned and sanitized once per day. Clean and sanitized at least every 4 hours.

35) Cardboard pizza rounds are being reused and were soiled with grease and residues. Cardboard is not acceptable for use as a utensil.

39) Prep refrigerator thermometer is broke.
